All of Kemper's services must be performed in a manner that furthers the Foundation's charitable and tax-exempt purposes, as determined in the sole discretion of the Foundation, and that principle shall at all times override any profit motive of Kemper Sports Management, Inc. The agreement has a five-year term with options for extension and certain early termination rights. The facilities remain the assets of the Foundation, and the revenues and most expenses continue to be the Foundation's; however the employees of the golf and food and beverage operations are Kemper employees.

Form 990, Part VI, Section B, Line 11b: After the Form 990 has been completed, the Senior Vice President of Operations reviews the document. Once the Senior Vice President is satisfied that the return has been accurately completed in accordance with IRS instructions, the return is reviewed for IRS compliance by the Foundation's legal counsel. The Treasurer and Foundation's legal counsel discuss and review the 990 tax return with, and a copy of the return is provided to, the Board of Directors during their regularly scheduled meeting.

If the Compliance Officer determines that there is in fact a conflict of interest involving an employee, the matter is disclosed to the Board of Directors. Conflicts identified involving a Board member are referred to legal counsel. Additionally, throughout the year, any third party interactions that may give rise to the appearance of a conflict of interest must be reported
